

VERSASTYLE STORIES GIVEAWAY RULES (the "Giveaway")

THIS CONTEST IS ONLY OPEN TO CANADIAN RESIDENTS (EXCLUDING QUEBEC) AND IS GOVERNED BY CANADIAN LAW AND THE LAWS OF THE PROVINCE OF ONTARIO.

GIVEAWAY PERIOD

- 1) The Giveaway begins on Friday, September 1, 2023 at 12:00 a.m. Eastern Time ("ET") and ends on Saturday, September 30, 2023 at 11:59 p.m. ET (the "Giveaway Period").

ELIGIBILITY

- 2) The Giveaway is hosted by Versastyle Dance Inc. (the "Competition")
- 3) The Giveaway is open to all residents of Canada (excluding Quebec) who have reached the age of majority in their province or territory of residence at the time of entry and that are a current dancer/student or employee of a Canadian dance studio or school (the "Studio").

HOW TO ENTER

- 4) NO PURCHASE NECESSARY. To participate in this Giveaway you must:
 - a. Have a valid Instagram account (an "Account"). If you do not have an Account, visit www.instagram.com and register in accordance with the enrollment instructions for a free Instagram account.
 - b. Become a follower (a "Follower") of the official @versastyledancecompetition (the "Channel").
 - c. During the Giveaway Period, interact with the Channel's Instagram Story by voting on a poll using your Account
- 5) You will receive one (1) Entry per day in the Giveaway (regardless of how many times you vote) when you interact with the Channel poll in accordance with these Rules. LIMIT (31) ENTRY PER PERSON/ACCOUNT DURING THE GIVEAWAY PERIOD. If it is discovered that you attempted to enter more than once during the Giveaway Period, then all your Entries will be void. Use of any automated system to submit Entries is prohibited and will result in disqualification.

DRAW AND WINNER SELECTION

- 6) On Sunday, October 1, 2023 in Toronto, Ontario, at approximately 10:00 a.m. ET, two (2) eligible entrants will be selected by random draw from all eligible entries received during the Giveaway Period. The odds of winning depend on the number of eligible entries received.
- 7) Before being declared a winner: The selected entrant will be contacted by private message on Instagram and notified that they are eligible to win. The selected entrant must reply by private message within one (1) business day of notification and provide the Competition with contact

information of the Studio at which they are a dancer, student and/or employee. The selected entrant must first correctly answer a time-limited mathematical skill-testing question to be administered by telephone. The Competition will then mail the prize to the Studio for the selected entrant to pick up.

- 8) The Studio may be required to sign and return within one (1) business day of notification a declaration of eligibility and a liability/publicity release, which:
 - a. confirms compliance with the giveaway rules;
 - b. grants to the Competition the right to use the selected entrant's name, The studio name, and likeness in any form of advertising relating to the giveaway without further notice or compensation.
